To maximize the lifespan of your roof and maintain warranty coverage, the following warranty terms and conditions apply:

#### 1. Warranty Coverage

All roof replacement options come with a comprehensive warranty that includes:

**Underlayment Warranty:** Coverage as per the manufacturer's warranty, ranging from 10 to 50 years depending on the underlayment type selected.
