To maximize the lifespan of your roof and maintain warranty coverage, the following warranty terms and conditions apply:

## 1. Warranty Coverage

All roof replacement options come with a comprehensive warranty that includes:

**Underlayment Warranty:** Coverage as per the manufacturer's warranty, ranging from 10 to 50 years depending on the underlayment type selected.

**Tile Warranty:** Coverage as per the manufacturer's warranty, ranging from 30 years to a lifetime, depending on the type of tile selected (standard concrete, premium concrete, or clay tiles).

**Warranty Activation:** The warranty will become effective on the date of completion of the roof installation.

**Maintenance Schedule:** The annual maintenance package is mandatory after the initial 5-year period to continue the coverage. Failure to comply with the annual maintenance schedule may void the warranty.

**Coverage Exclusions:** The warranty does not cover damage caused by natural disasters, improper use, or modifications made to the roof after installation without prior consultation with Valleywide Pro Roofing, LLC. The warranty does not cover any work performed by other roofing contractors or companies not associated with Valleywide Pro Roofing, LLC.

**Warranty Transfer:** The warranty is transferable to a new homeowner upon the sale of the property, provided that all maintenance requirements have been met. A **one-time transfer fee of \$250** is required to transfer the warranty to the new homeowner.
