- This proposal applies to the entire Tile Roof @ **38 sq's + 4 sq's Patio.**
- Remove tile and set aside.

- —Remove felt and remove and replace battens from the entire tile roof.
- —Remove and replace any sheets of bad plywood (as needed) throughout the roof. Additional plywood billed at \$80/sheet.
- —Install new SBS rolled roofing as needed.
- —Install new **30-Year Underlayment** over the entire tile roof.
- —Re-install tile over the entire roof, replacing any as needed, matching color as close as possible.
- —Install new 3 inch x 3 inch drip edge around the perimeter of the entire tile roof.
- —Install new ribbed valley metals, and channel metals as needed throughout the tile roof.
- —Install new L metals, roof jacks, T-Top air vents, and O'Haggin vents throughout the tile roof as needed. (proper ventilation)
- —Install new ridge and hip enclosures as needed throughout the tile roof.
- —Install new bird stops as needed throughout the roof.
- —Seal all penetrations, haul away debris, and clean.
- —Provide **30-YEAR** warranty over the entire Tile roof.

To maximize the lifespan of your roof and maintain warranty coverage, the following warranty terms and conditions apply:

1. Warranty Coverage

All roof replacement options come with a comprehensive warranty that includes:

Underlayment Warranty: Coverage as per the manufacturer's warranty, ranging from 10 to 50 years depending on the underlayment type selected.

Tile Warranty: Coverage as per the manufacturer's warranty, ranging from 30 years to a lifetime, depending on the type of tile selected (standard concrete, premium concrete, or clay tiles).

2. Maintenance Requirements

Warranty Activation: The warranty will become effective on the date of completion of the roof installation.

Maintenance Schedule: The annual maintenance package is mandatory after the initial 5-year period to continue the coverage. Failure to comply with the annual maintenance schedule may void the warranty.






Coverage Exclusions: The warranty does not cover damage caused by natural disasters, improper use, or modifications made to the roof after installation without prior consultation with Valleywide Pro Roofing, LLC. The warranty does not cover any work performed by other roofing contractors or companies not associated with Valleywide Pro Roofing, LLC.
