## Warranty Statement for Roof Replacement Options

Thank you for choosing Valleywide Pro Roofing, LLC for your roofing needs. We are committed to providing high-quality materials and professional installation to ensure the longevity and performance of your new roof. To maximize the lifespan of your roof and maintain warranty coverage, the following warranty terms and conditions apply:

### 1. Warranty Coverage

All roof replacement options come with a comprehensive warranty that includes:

**Underlayment Warranty:** Coverage as per the manufacturer's warranty, ranging from 10 to 50 years depending on the underlayment type selected.

**Tile Warranty:** Coverage as per the manufacturer's warranty, ranging from 30 years to a lifetime, depending on the type of tile selected (standard concrete, premium concrete, or clay tiles).

**Shingle Warranty:** Coverage as per the manufacturer's warranty, typically ranging from 20 to 50 years depending on the type and grade of shingles selected (standard 3-tab, architectural, or premium shingles).

**Coverage Exclusions:** The warranty does not cover damage caused by natural disasters, improper use, or modifications made to the roof after installation without prior consultation with Valleywide Pro Roofing, LLC. The warranty does not cover any work performed by other roofing contractors or companies not associated with Valleywide Pro Roofing, LLC.

**Warranty Transfer:** The warranty is transferable to a new homeowner upon the sale of the property, provided that all maintenance requirements have been met. A **one-time transfer fee of \$250** is required to transfer the warranty to the new homeowner.
